

Defendant filed Reply to Plaintiff's New Matter to Preliminary Objections to Complaint as well as Brief in Support.

## May 31, 2005

Plaintiff filed Sur-Reply Brief in Opposition to Preliminary Objections. Copy forwarded to Defendant.

#### June 15, 2005

Board rendered an Opinion and made the following Order: "AND NOW, this 15<sup>th</sup> day of June, 2005, it is ORDERED and DECREED that Defendant's Preliminary Objections are OVERRULED with leave of Defendant to file a responsive pleading within twenty (20) days of the exit date of this Order.

#### June 22, 2005

Defendant filed letter advising that Plaintiff has agreed to an extension until August 4, 2005 for Defendant to file their responsive pleading to Plaintiff's Complaint.

#### July 22, 2005

Defendant filed letter advising that Plaintiff has agreed to a second extension until September 6, 2005 for Defendant to file their responsive pleading to Plaintiff's Complaint.

#### August 29, 2005
