Plaintiff filed Claim and filing fee. Amount of Claim: \$2,250.00.

March 30, 2005

Board called Plaintiff advising of filing deficiency: lacks 3 copies, proof of mailing and proper verification. Mailed notice of deficiency to Plaintiff.

April 25, 2005

Plaintiff forwarded to the Board three additional (3) copies of Complaint.

April 25, 2005

Board called Plaintiff advising of filing deficiency: proof of mailing and proper verification. Mailed notice of deficiency to Plaintiff.

June 15, 2005

Plaintiff filed proof of mailing claim to Defendant and verification. ACCEPTED FOR FURTHER PROCESSING.

June 21, 2005

Attorney General filed Acknowledgment of Claim form. Receipt of same acknowledged June 17, 2005.

July 13, 2005

Defendant filed a letter advising that Defendant has not received a copy of the Claim.

July 26, 2005

Defendant filed letter addressed to Plaintiff advising that Defendant would like to settle and attached a stipulation of Settlement and Release.

July 28, 2006

Board issued letter to parties requesting a status report.

August 1, 2006

Defendant filed (via Facsimile) a Settlement Agreement which was executed by both parties.

August 14, 2006

The Board rendered the following order: **AND NOW**, this 14th day of August, 2006, the Board acknowledges receipt of a Stipulation of Settlement and Release of Claims, executed by Jeffrey Cooper, Chief Counsel, on behalf of Defendant, and Sheldon R. Gelman, Ph.D., on behalf of Plaintiff, which states "...By signing this document, Contractor expressly authorizes and requests the discharge of the Board of Claims action at Docket No. 3760 with prejudice...", docketed with this Board under date of August 1, 2006.
