Order as follows: "AND NOW, this 12th day of May, 2008, upon consideration of the motion of plaintiff Frank Lill & Son, Inc., for judgment on the pleadings, it is hereby **ORDERED** that the motion is **GRANTED** and final judgment in the amount of \$81,605 (composed of \$75,000 plus pre-judgment interest in the amount of \$6,605) is entered on behalf of plaintiff, Frank Lill & Son, Inc. and against the defendant, Commonwealth of Pennsylvania, Department of Public Welfare. Plaintiff Frank Lill & Son, Inc. is also awarded post-judgment interest on the outstanding judgment at the statutory rate of 6% per annum from the exit date of this Order until the judgment is paid in full. Plaintiff's request for penalty interest and attorney fees is also GRANTED for the reasons stated in our opinion, and it is hereby ORDERED and DIRECTED that plaintiff Frank Lill & Son, Inc. submit to the Board an itemized listing of the attorney fees, costs and a calculation of penalty fee it claims for this matter pursuant to 62 Pa.C.S.A. § 3935. These itemizations shall be submitted to the Board within 20 days of the exit date of

this Order. The Department shall then have 20 days from the submission of such itemized list of attorney fees, costs and penalty calculations to respond. In the event the Department contests any of the fees, costs or penalty calculations and the parties are unable to stipulate to agreed upon amounts within 40 days from the exit date of this Order, the Board will hold an evidentiary hearing on same and issue a supplemental order respecting these fees, costs and penalty awards only.
