(Wheeler) on December 12, 2023, the preliminary objections and supporting brief filed by the Commonwealth of Pennsylvania, Department of Transportation (PennDOT) on January 3, 2024, and the Praecipe to Dismiss filed by PennDOT on February 7, 2024, which Wheeler has failed to contest, it is hereby **ORDERED** and **DECREED** as follows: 1. PennDOT's preliminary objections 1, 2, 4, and 5 are **SUSTAINED**. 2. PennDOT's preliminary objection 3 is **OVERRULED**. 3. PennDOT's preliminary objection 6 is **SUSTAINED IN PART**. The letter addressed to State Senator Langerholc is stricken from the statement of claim. 4. The statement of claim is **DISMISSED** without prejudice to file an amended claim that complies with the Board of Claims Rules of Procedure and the Pennsylvania Rules of Civil Procedure within 20 days of the date of service of this order."
