September 30, 1982 The Board rendered an Opinion and made the following Order: "AND NOW, this 30th day of September, 1982, an Award is made in favor of Claimant, Gail L. Miller and against the Commonwealth of Pennsylvania, Department of Education, in the sum of Five Hundred Sixteen Dollars and One Cent (\$516.01), together with interest at the legal rate of six (6%) per cent per annum from May 1, 1981. The Claim of the Commonwealth of Pennsylvania, Department of Education, Millersville State College for restitution is DENIED. Each party to bear its own costs."

October 6, 1982 Copies of Opinion and Order dated September 30, 1982 forwarded to attorney for plaintiff and attorney for defendant.
