The Board rendered an Opinion and made the following Order: "AND NOW, this 30th day of August, 1985, it is hereby ORDERED as follows: 1. The Claim of Anne U. Barnes, M.D. for payment for services in accordance with the weighted salary scale for the period from September 10, 1977 through November 13, 1981, is DENIED. 2. The Claim of the Department of Public Welfare for reimbursement of salary paid in accordance with the weighted salary scale for the period from March 29, 1976 to September 9, 1977 is DENIED. 3. The Department of Public Welfare is directed to compute the salary due Anne U. Barnes, M.D. for each pay period from September 9, 1977 to November 13, 1981, together with interest at the lawful rate of six (6%) percent from the date of payment for each pay period. Any amounts paid to Claimant together with interest at the lawful of six (6%) percent from the date received shall be credited to the Commonwealth. Any difference between the amounts due and amounts received shall be entered as a judgment in favor of the party entitled thereto, and bear interest at the lawful rate of six (6%) percent. 4. Each party to bear its own costs." Copies forwarded to attorney for plaintiff and attorney for defendant.
