February 8, 1983 Stipulation filed by attorney for plaintiff and attorney for defendant in Commonwealth Court.

February 15, 1983 Copy of Complaint forwarded to attorney for Defendant and Deputy Attorney General.

February 28, 1983 Stipulation to stay proceedings filed by parties.

March 14, 1983 The Board rendered an Opinion and made the following Order: "The Board accepts the Stipulation and Grants and Directs that the above-captioned action be stayed pursuant to said Stipulation and further, that at this time no responsive pleading is required to be filed by the Commonwealth with regard to the Complaint." Copies forwarded to all counsel of record.

March 15, 1983 The Board rendered an Amended Opinion and made the following Order: "The Board accepts the Stipulation and Grants and Directs that the above-captioned action be stayed pursuant to said Stipulation and further, that at this time no responsive pleading is required to be filed by the Commonwealth with regard to the Complaint." Copies forwarded to all counsel of record.

January 28, 1985 Order to Stay filed by attorney for Plaintiff. Copy forwarded to attorney for Defendant by attorney for Plaintiff.

February 7, 1985 The Board rendered an Opinion and made the following Order: "AND NOW, this 7th day of February, 1985, it is ORDERED and DIRECTED upon Motion to Stay the instant matter until final conclusion of the litigation between the parties hereto in the Commonwealth Court of the Commonwealth of Pennsylvania, Docket No. 1524 C.D. 1982, that said action be stayed." Copies forwarded to attorney for plaintiff and attorney for defendant.

March 3, 1991 The Board rendered an Opinion and made the following Order: "AND NOW, this 3rd day of March, 1991, as a result of a review of the documentation and the records contained in this file, it is ORDERED and DIRECTED that, in that the jurisdiction of this matter is with the Commonwealth Court of the State of Pennsylvania, said matter is DISMISSED with prejudice." Copies forwarded to attorney for Plaintiff and attorney for Defendant.
