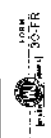

July 31, 1985 The Board made the Order: "RULE TO SHOW CAUSE. AND NOW, this 31st day of July, 1985, the Board of Claims issues this Rule to Show Cause on Claims returnable within thirty (30) days from the date above, why this matter should not be dismissed for failure to prosecute this claim. There appears to be a basis for such an action that Claimants have ceased all activity with respect to this claim since September 24, 1984. If no Answer is timely filed to this Rule, this Rule shall become absolute and this claim dismissed." Copies forwarded to attorney for Plaintiff and attorney for Defendant.
