October 30, 1986 The Board rendered an Opinion and made the following Order: "AND NOW, this 30th day of October, 1986, after due consideration of the testimony and the record in the instant case, the Board of Claims finds in favor of the Plaintiff, Soldiers and Sailors Memorial Hospital, and against the Defendant, Commonwealth of Pennsylvania, Department of Public Welfare, and hereby makes an award to the Plaintiff in the amount of \$22,838.50 with interest, at the legal rate of six (6%) percent per annum from January 24, 1984. Each party to bear its own costs." Copies forwarded to attorney for Plaintiff and attorney for Defendant.
