

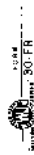

January 11, 1985	Respondent's Preliminary Objections to Claimant's Complaint filed by attorney for defendant. Copy forwarded to attorney for plaintiff by attorney for defendant.
January 24, 1985	Respondent's Memorandum of Law in Support of Preliminary Objections filed by attorney for defendant. Copy forwarded to attorney for plaintiff by attorney for defendant.
May 6, 1985	Stipulation and Proposed Order filed by attorney for Plaintiff. Copy forwarded to attorney for Defendant by attorney for Plaintiff.
May 17, 1985	The Board rendered an Opinion and made the following Order: "AND NOW, this 17th day of May, 1985, pursuant to Stipulation of Counsel, heretofore named, the parties agree that the action pending in the above captioned matter be deferred and stayed pending the results before the Department of Public Welfare. Said inference of the above matter shall not result in prejudice to either party. Further, it is ORDERED and DIRECTED by this Board that either party, upon reasonable reason shown may request that the stay herein granted be dissolved and the matter be ordered for hearing on the merits. A status report should be furnished to the Board every thirty (30) days beginning from the date of this Order." Copies forwarded to attorney for Plaintiff and attorney for Defendant.
January 9, 1987	Stipulation of Settlement executed by attorney for plaintiff and attorney for defendant and filed by attorney for defendant.
February 11, 1987	The Board rendered an Opinion and made the following Order: "AND NOW, this 11th day of February, 1987, upon consideration of the Stipulation of Settlement as filed by Bruce G. Baron, Assistant Counsel for Defendant, and letter of Daniel F. Glasswire, Esquire, Counsel for Plaintiff requesting discontinuance pursuant to said Stipulation of Settlement, it is hereby ORDERED and DECREED that the above captioned matter be and hereby is, discontinued and ended with prejudice."
